Greetings Trinity members,

I am writing to you on behalf of the Call Committee. First of all, we have some good news to share! As some of you are already aware, the church recently received our official call list from the Kansas District office, along with a packet of information on each pastoral candidate. This list of 14 candidates is shown below. Your Call Committee has already begun reviewing the information received and will likely have several meetings over the next month or so as we prepare to make recommendations to the voters for issuing a Divine Call to our next pastor. Please continue to keep this process and the members of our Call Committee in your prayers.

In the meantime, we are required to allow a period of time during which any communicant member in good standing shall have the right to file a valid objection with the chairman of the Call Committee or the Board of Lay Ministry to any candidate on the official call list. A valid objection is one in which a person cannot in good conscience or on moral grounds accept the man in question as his or her pastor. If such an objection is made and sustained as valid by the Board of Lay Ministry or the Call Committee, the candidate in question shall be removed from the call list by the voters assembly. Thus, if any member would like to file an objection to any candidate on our call list (shown below), please contact me, as chairman of the Call Committee, or any one of our other Lay Ministers (Jerry Bitter, Robert Drees or Buddy Skeie) by March 15, 2016. Thank you.





### Seeing is Believing

"I'll believe it when I see it." We've heard the claims far too many times:

advertisers promising us that their products are the best; politicians promising us a far better future than we could ever imagine if only they are elected; family and friends making promises they never intend to keep. The world has made us skeptics. In order for us to believe something is true, we need evidence-- something tangible that we can see with our own eyes. If we cannot see it, and it sounds too good to be true, it probably is.

So it was with Thomas, one of Jesus' disciples. He heard the good news from his fellow disciples that Jesus had risen from the dead, and that they had seen Jesus. Thomas, however, was not there in that locked room when Jesus first appeared to them, and he refused to believe. He wanted real, tangible proof that Jesus had actually risen from the dead. He wanted to see Jesus with his own eyes in order to believe what the other disciples had told him.

In John 20:29, Jesus says to Thomas, "Have you believed because you have seen me? Blessed are those who have not seen and yet have believed." Thomas received the proof that he needed in order to believe that Jesus had, in fact, risen from the dead. However, we do not have the luxury of seeing Jesus' resurrected body as those disciples did some 2,000 years ago. How are we able to believe since we have not seen with our own eyes?

Read the explanation to the Third Article of the Apostles' Creed from Luther's Small Catechism with Explanation.

### What does this mean?

I believe that I cannot by my own reason or strength believe in Jesus Christ, my Lord, or come to Him; but the Holy Spirit has called me by the Gospel, enlightened me with His gifts, sanctified and kept me in the true faith. In the same way He calls, gathers, enlightens, and sanctifies the whole Christian church on earth, and keeps it with Jesus Christ in the one true faith. In this Christian church He daily and richly forgives all my sins and the sins of all believers. On the Last Day He will raise me and all the dead, and give eternal life to me and all believers in Christ. This is most certainly true.

By the power of the Holy Spirit working in our lives through the Means of Grace, God's Holy Word, and the Sacraments of Holy Baptism and Holy Communion, God gives to us and keeps us in the faith through which we believe in His promises. Through the faith we have received, God shows His great love for us that sent Jesus to die on the cross on our behalf. As God's children, redeemed by the Lamb of God who takes away the sin of the world (John 1:29), God leads us to repentance and promises us forgiveness and everlasting life.

### TRINITY LUTHERAN CHURCH – VOTERS' MEETING MINUTES OF THE MEETING JUNE 28, 2015, 1:00 p.m.

Forty-nine people signed the attendance roster.

Jay Meyer called the meeting to order and Pastor Timm Griffin opened with "Flawed but Valuable to God" devotion and prayer.

Minutes from the January 25, 2015 Voters' meeting was presented. Ron Hall requested that the spelling of Steve Hamman's name be corrected on Page 2 in the 2<sup>nd</sup>

paragraph. Roger Reetz moved and Lisa Theye seconded that the minutes be approved as corrected. The motion passed by voice vote.

Jim Hewes reported that the Task Force is made of up of 7 members and it meets on Mondays. They have completed the review of the Cottage Meeting input and will be

targeting two areas – Leadership and Communication. The Task Force will break into two committees with each focusing on one area. On June 10<sup>th</sup> the Task Force presented their findings to the Church Leadership Council. The Task Force will also be drafting a job description of the Pastor and questions for the Call Committee to use.

Loretta Schultz presented the following financial information:

12/31/14 Year End Surplus was \$137,086. Remodeling Project Contractor: \$183,609 Other Expenses: \$24,684 Total: \$208,293 Donations \$108,662 Balance as of 5/3/15: \$99,631

No funds have been borrowed from LCEF. It was announced that the Long Range Planning Committee will be presenting fundraising ideas to the Church Leadership Council in the coming months. Loretta also reported on the 12/31/14 Fund Balances including Restricted Funds, Dillions Rewards and Thrivent Choice Dollars. The Dillions program is split 1/3 to Family Life/Education, 1/3 to Youth and 1/3 Capital Fund. The Dillons program is currently known as Community Rewards and Trinity's current balance is \$376. She also reported that the Thrivent Choice balance is currently \$8,510. Applications are available for these funds and are spent with the approval of 2 of the 3 Called Servants.

Pastor Wehling from Grace Lutheran in Liberal, who is the Circuit Visitor, presented two handouts on the call process. The handouts were the Pre-Call Meeting and Calling a Pastor in a Time of Pastoral Vacancy (see attached). Pastor Wehling reviewed the information on these handouts with those in attendance. Current Trinity By-Laws instructed the Church Leadership Council to form the Call Committee and it will be comprised of the following: 2 DCEs, 5 members of the congregation and 2 Lay Ministers. It was requested that nominations be submitted.

The old business to be acted upon is the disbursement of the 2015 Royalties and the Additional Tithe amount. The Additional Tithe amount is \$8,865. It was shared that the Office of International Missions is sponsoring Medical Missions and that Melanie Algrim will be going on a mission in October. Discussion followed on possible missions to support. Steve Hamman moved to support Melanie Algrim's mission with the Additional Tithe amount. The motion was seconded by Chuck Messenger. Discussion followed. Motion was defeated by voice vote. Additional discussion followed. Heidi Berg called the question. Fern Becker moved that an Ad Hoc committee be established to research missions to support and that the committee present their findings at the January Voters' Meeting for the Voters decision. Clara Faye Schweer seconded. Motion passed by voice vote. Jay Meyer requested that DCE Cynthia Lavrenz be in charge of the Ad

Hoc committee and she agreed. The 2015 Royalties amount is \$9,436. Jerry Bitter moved that the 2015 Royalties be delegated to the Church Leadership Council for appropriate expenditure. Fern Becker seconded the motion. Voice vote was held, it was too close to call so a hand vote was held and motion passed 25 to 11.

The floor was opened for new business.

Jay Meyer reported that Carlene Schweer has completed her term on the Endowment Board and that she is willing to serve another term. Jay Meyer stated that the Endowment Board recommends that Carlene Schweer be appointed to serve until June 30, 2019. Floor was opened for nominations. Chuck Messenger was nominated. Alice Banning moved that nominations cease, it was seconded by Jared Froetschner and the motion was passed by voice vote. Voting was done by ballot and Chuck Messenger was elected to serve with Jay Meyer, Judy Nusser and Gerry Schultz on the Endowment Board.

The Endowment Board's 2014 Annual Report was printed in the June Newsletter (see attached). Jay Meyer reported that the yearly income from the Endowment Fund is \$4,761, so 25% is \$1,125. It is the unanimous recommendation of the Endowment Board to the Voters that 25% of the 2014 income be approved by the Voters for use as follows: \$250 to Vacation Bible School, \$875 to Piecemakers and \$65.23 be added to principal for continued growth. Jay Meyer moved that the Trinity's 25% be allocated in accordance with the Endowment Boards recommendation. Motion was seconded by Jim Hewes and passed by voice vote.

Jay Meyer reported that Ron Hall had completed his term on CLC (Lay Minister) and he thanked Ron for his service. Current Lay Ministers are Jay Meyer, Bob Drees and Buddy Skeie. Requirements to serve on CLC are: Regular attendance in worship, Active in Bible Study and a Member of Trinity Lutheran Church for two years. Jay Meyer presented the following ballot for the Lay Minister Position: Jerry Bitter and Jared Froetschner. Jay Meyer opened the floor for nominations. No nominations were offered. Jared Froetschner moved nominations cease. Motion was seconded by Mike Reagle and motion passed by voice vote. Voting was held by ballot and voters were instructed to vote for one Lay Minister candidate. CLC member for the Lay Minister Position elected was Jerry Bitter.

It was reported that the 2014 Guinea Partnership was pledged to the Heiney's and will be submitted when the \$6,000 is reached. The balance as of December 31, 2014 is \$4,327. Jerry Bitter moved that monies received as of June 30, 2015 be submitted. Paul Pauley seconded the motion and it passed by voice vote.

Jay Meyer reported that Heidi Berg and Lisa Hogan had completed their CLC terms and he thanked them for their service.
